The tender should be submitted by email at tender@bahkc.org.hk OR in person to the Board of Directors of the Badminton Association of Hong Kong, China Limited at Room 2005, 2/F, Olympic House, 1 Stadium Path, Causeway Bay, Hong Kong, and must be delivered by 4:00 PM on Monday, May 26, 2025, to the aforementioned address. Late tenders will not be accepted. The tender form must be placed in a sealed envelope. The envelope should be clearly marked with: " Supply of Tournament Lighting for LI-NING Hong Kong Open Badminton Championships – Badminton Association of Hong Kong, China Limited." If, between 9:00 AM and 4:00 PM on the deadline day, the Hong Kong Observatory issues a Black Rainstorm Warning or a Typhoon Signal No. 8 or above, the submission deadline will be extended to 4:00 PM on the next working day (excluding Saturdays, Sundays, and public holidays). The Badminton Association of Hong Kong, China reserves the right to invite selected suppliers to provide a detailed presentation of their tender submissions.

Please note that your tender will remain valid for 90 days from the closing date mentioned above. If no order is placed within this period, the tender will be considered unsuccessful. Additionally, please ensure that the tender form and the Declaration of Interests form are fully completed; otherwise, the tender will not be considered.


The tender envelope must not display the identity of the Bidder. If the bidder discloses their identity on the sealed envelope, the tender will be disqualified. If the bidder is permitted to amend their tender after submission but before the deadline, the revised tender must be submitted in the same manner as the original submission.

Bidder, their employees, and agents are prohibited from offering any benefits (as defined under the Prevention of Bribery Ordinance, Cap. 201) to employees or board members of the Badminton Association of Hong Kong, China Limited, or to any individuals involved in the consideration of matters related to this contract. Offering such benefits may constitute a criminal offense under the Prevention of Bribery Ordinance and could result in the contract being invalid. The Badminton Association of Hong Kong, China Limited also reserves the right to cancel the awarded contract, and the bidder will be held legally responsible for any losses or damages incurred by the Association.

If your company does not intend to submit a tender, please promptly return the tender form to the address above, stating the reason for not bidding.
